Description

1. The PNP Police Regional Office BAR, through the MOOE 2023 intends to apply the sum stated below being the ABC to payments under the contract for the Supply and Delivery of One Lot Ammunition for FY 2023/PRO BAR-2022-16. Bids received in excess of the ABC for each sub-lot shall be automatically rejected at bid opening.

DELIVERY PERIOD: Delivery of Goods is required within 20 calendar days upon receipt of the Notice to Proceed. The delivery may be extended for a period of 15 calendar days provided that the bidder can show proof of justifiable circumstances for its extension or as set in the Schedule of Requirements.

2. The PNP Police Regional Office BAR now invites bids for the above Procurement Project. Delivery of the Goods is required within 20 calendar days upon receipt of Notice to Proceed or within the first week of the month for the succeeding deliveries. Bidders should have completed, within five years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.

a. Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA No. 5183.

4. Prospective Bidders may obtain further information from PNP Police Regional Office BAR and inspect the Bidding Documents at the address given below during weekdays from 8:00 AM to 5:00 PM.

5. A complete set of Bidding Documents may be acquired by interested Bidders on November 23, 2022 – December 13, 2022 from the given address and website(s) below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Twenty-Five Thousand Pesos (P25,000.00). The Procuring Entity shall allow the bidder to present its proof of payment for the fees in person.

6. The PNP Police Regional Office BAR will hold a Pre-Bid Conference on December 1, 2022 at exactly 9:00 AM at the Conference Room, Admin Building, Camp BGen Salipada K Pendatun, Parang, Maguindanao and/or through videoconferencing/webcasting via zoom, which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below on or before December 13, 2022 at 9:00 AM. Late bids shall not be accepted.

8. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 14.

9. Bid opening shall be on December 13, 2022 at 9:00 AM at the given address below. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity.

10. The PNP Police Regional Office BAR reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised IRR of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
